- processing your application and/or refund cheque and/or an e-Auto Refund payment, when applicable; verification of compliance with the terms and application procedures set out in this Application Form and the Prospectus and announcing results of allocation of the Hong Kong Offer Shares;
- compliance with applicable laws and regulations in Hong Kong and elsewhere;
- registering new issues or transfers into or out of the names of securities holders including, where applicable, HKSCC Nominees;

- establishing benefit entitlements of securities holders of the Company, such as dividends, rights issues, bonus issues, etc.;
